- NO TIME TAKEN OFF FOR MINOR AILMENTS
- PROVIDE THE SCHOOL WITH MORE
 THAN 1 EMERGENCY CONTACT
- BUILD A ROUTINE THAT PROMOTES

FIRST TIME - £160 PER PARENT PER
CHILD WHEN PAID WITHIN 28 DAYS.
REDUCED TO £80 PER CHILD IF PAID
WITHIN 21 DAYS

SECOND TIME - £160 PER PARENT PER CHILD WITHIN 28 DAYS. NO REDUCTION

THIRD TIME - CASE TO MAGISTRATES
COURT AND POSSIBLE FINE OF UP TO
£2,200

WHEN THE SCHOOL BECOMES AWARE
THAT THE NATIONAL THRESHOLD HAS
BEEN MET A PENALTY NOTICE MUST BE
CONSIDERED.
