

Evaluation of West London Zone Early Intervention Programme July 2020-October 2024

West London Zone is funding the Centre for Education Policy and Equalising Opportunities at UCL Institute of Education to carry out research into the effectiveness of their programme. This research has been reviewed and approved by the research ethics committee of UCL Institute of Education.

The project is investigating the effect of the West London Zone early intervention programme. There's more information about West London Zone's work in the documents they have provided along with this information sheet. This information sheet specifically relates to the work that we will be doing with West London Zone to understand how their programme is working.

Who is carrying out the research?

The Centre for Education Policy and Equalising Opportunities at the UCL Institute of Education, specifically a team led by Dr Jake Anders, including Profs. Lindsey Macmillan and John Jerrim, and Drs. Asma Benhenda and Gill Wyness.

Why are we doing this research?

We are aiming to understand whether and how the work done by West London Zone improves outcomes for participants. We will do this by comparing participants' outcomes with those of other pupils in their school, in their local area, and across the country.

What will happen as part of this research?

West London Zone will share data that it collects as part of delivering its programme with the research team at UCL Institute of Education so that we can analyse it to provide evidence on the effectiveness of the programme.

West London Zone may ask your child to complete a questionnaire towards the end of the school year. West London Zone asks participants in its programme to complete this questionnaire as part of its programme delivery. We are asking that some non-participants also complete the questionnaire for the purposes of the research project (so that they can be compared). All those asked to complete the questionnaire (whether participants in the West London Zone or not) will be told that they do not have to complete the questionnaire if they do not want to do so, or can stop at any time.

We are also asking WLZ to share your child's Unique Pupil Number (issued by the UK Government's Department for Education) with us. This will allow us to link up programme data with the Department for Education's National Pupil Database and other official records. This would, in turn, allow us to gain a longer term understanding of the outcomes of participating in the West London Zone programme (for example by looking at GCSE scores) when they are older. This involves us sharing data with the Department for Education.

Will anyone know I have been involved?

No information that can identify individual children will be made available to anyone outside the research team (other than for the purposes of linking with the National Pupil Database, which follows established and highly secure procedures). The data will all be kept securely under password protection. We will not use your child's name or the name of their school in any report arising from the research, and no information that could otherwise identify your child will be made public.

Can I object to my child's data being used for this purpose?

It is entirely up to you whether or not your child's data is shared with UCL as part of this project. Your decision either way will not affect the way that West London Zone delivers its work or how it engages with your child. We think this project will have important benefits for the understanding of how to improve children's academic and wellbeing outcomes, and will not negatively affect your child in any way. However, we respect your right to ask us not to use your child's data in this way. If you wish to exercise this right, then please complete the form included with this letter, and no data of your child's will be shared with UCL. You can also choose to exercise this right at any point during the project: please contact the research team using the details below and we will securely destroy any personal data we hold about your child.

The legal basis that would be used to process your child's personal data will be performance of a task in the public interest. The legal basis used to process special category personal data will be for scientific and historical research or statistical purposes. Your child's personal data will only be processed so long as it is required for the research project. If we are able to anonymise or pseudonymise the personal data we are processing then we will undertake this, and will endeavour to minimise the processing of personal data wherever possible.
